1. **Jurisdiction.** The event will be held under the General Competition Rules and Standing Regulations of the Motor Cycle Union of Ireland, the MRA and these Supplementary Regulations and any further Regulations subsequently issued.

2. **Eligibility.** The event is open to drivers holding a current 2024/25 competition licence issued by the MRA, MCUI, ACU or SACU. The promoters require holders of ACU and SACU competition licences to show evidence of the required Medical Expenses and Repatriation cover before permitting a start.

6. **Classes.** The trial will be for Expert Elite, Experts, Semi-Experts, Clubman, Sportsman. Youth Grades A, B, C main course only.

7. **Course.** The course will be marked with direction arrows or flags indicating the desired route between sections.

8. **Start and Finish.** Drivers will be issued both a data and punch card at the start and **must submit** data card for scanning score at completion of each lap and at the finish or on **retiring**. **Anyone who does not start at his due time will receive no allowance of time for late starting.**

9. **Time.** The time allowed to complete the trial shall be 5 hours.

10. **Sections.** The No of sections and laps to be defined at start, must be attempted in the correct order. The sections will be indicated by **Start Markers** at the start and **End Markers** at the finish. In between coloured gates to coincide with rider's bib colour.
